RESOLUTION NO.22-04**

**CANVASSING THE ELECTION RETURNS AND DECLARING THE RESULTS OF THE  
GENERAL ELECTION HELD NOVEMBER 8, 2022**

WHEREAS, Notice was duly given by this Navigation and Canal Commission of the Aransas County Navigation District for a general election to be held on November 8, 2022 for election of Commissioners from precincts 2, 4-4A, and At Large; and

WHEREAS, a contract for election services was made with the Aransas County Elections Administrator for the conducting of the election in accordance with the Texas Election Code and the Elections Administer has so conducted the election; and

WHEREAS, the Elections Administrator has delivered to this Commission the precinct returns from the election as shown in 2 reports titled "AC Navigation District Precinct Results" and "AC Navigation District Cumulative Results", both dated 11/15/22, (the Returns); true copies of which are incorporated as Exhibits 1 and 2 to a copy of the Summary of Precinct Results, attached hereto as Exhibit A; and

WHEREAS, the Elections Administrator has delivered to this Commission a report titled "AC Navigation District Canvass Results", a true copy of which is incorporated as Exhibit 1 to a copy of the Canvass of Election, attached hereto as Exhibit B; and

WHEREAS, this Commission, acting as the canvassing authority, has convened a meeting duly noticed and held on November 21, 2022, canvassed the Returns, and made all other inquiries it deems necessary; and the Commission finds the Returns to be in order and in accordance with the Election Code.

**WHEREFORE, be it hereby resolved by the Navigation and Canal Commission of the Aransas County Navigation District as follows:**

1. The Commission has canvassed the Returns for the election for Commissioners in precincts 2, 4-4A, and At Large as shown in Exhibit A, and Resolves that the Returns are in order and are accepted, and declares the attached Returns to be the official results of the general election; and

2. The following persons are accordingly declared to have been elected to the office of Commissioner of the Navigation and Canal Commission, each for a term commencing on January 1, 2023:

Precinct 2: Martin Diaz De Leon

Precinct 4-4A: Long Nguyen

At Large: Tommy Moore


3. 5. A copy of this Resolution, with all exhibits, shall be entered into the District's election register together with any other information as may be required to be so entered under the Election Code; and
6. The Chairman, Vice Chairman, and Secretary, singly or jointly as may be appropriate, are authorized to execute and deliver all such additional instruments and perform such other acts as may be required or deemed necessary in connection with or relating to the election or the results thereof; and
7. The recitals contained in the preamble hereof are true; are findings of this Commission; and are incorporated in this Resolution for all purposes. All exhibits attached hereto are fully incorporated herein.




